FACTS	WHAT DOES ALICE DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>• Social Security number and credit and debit card numbers</li> <li>• account balances and transaction information</li> <li>• employment information and payroll information</li> <li>• medical insurance information and pretax benefits claim information</li> </ul> <p>When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.</p>
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Alice chooses to share; and whether you can limit this sharing.

Reasons we can share your personal information	Does Alice share?	Can you limit this sharing?
<b>For our everyday business purposes</b> – such as to process your transactions, maintain your account(s), respond to court orders and legal investigations, or report to credit bureaus	Yes	No
<b>For our marketing purposes</b> - to offer our products and services to you	Yes	No

<b>For our affiliates' everyday business purposes</b> – information about your transactions and experiences	No	We don't share

<b>For nonaffiliates to market to you</b>	No	We don't share

## What we do

How does Alice protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Alice collect my personal information?	We collect your personal information, for example, when you <ul style="list-style-type: none"> <li>enroll in Alice or open a connected account</li> <li>used your connected credit or debit card</li> <li>submit claims for your pretax spending transactions</li> </ul> We also collect your personal information from others, such as your employer, their payroll processing company, or other companies.
Why can't I limit sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none"> <li>sharing for affiliates' everyday business purposes—information about your creditworthiness</li> <li>affiliates from using your information to market to you</li> <li>sharing for nonaffiliates to market to you</li> </ul> State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.






## Definitions

Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>We do not have affiliates.</li> </ul>
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> <li>We do not share with nonaffiliates for marketing purposes.</li> </ul>
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> <li>We do not share with nonaffiliates for joint marketing purposes.</li> </ul>








## Other important information

Depending on where you live, you may have additional privacy protections under some state laws. We will comply with applicable state laws before sharing nonpublic personal information about you. We may do this by sending a separate notice of those rights to you.
